At the University of Greifswald's Chair of **Economics, Health Economics and Econometrics** in the **Faculty of Law and Economics**, there is a job vacancy that is **expected to be available for earliest possible appointment**, subject to budgetary regulations, for a part-time **(50 %)**

(postdoctoral) Teaching Associate

The position on offer is **permanent**. Payment will be made according to pay group 13 *TV-L Wissenschaft*.

Job description:

- Services mainly in teaching (8 classes à 45 Min. per week pursuant to LVVO M-V)
- Planning and holding of classes for the quantitative basic training of students in economics, in particular lectures and exercises on mathematics for economics
- Exam preparation, exam supervision and correction of exams
- Organisation of bridging courses for quantitative subjects
- Organisation of tutorials
- Administrative support for the department's activities in the field of quantitative basic education

Job requirements:

- University degree (master's/Diplom) in the field of economics or in a related degree course that has been successfully completed by the time employment starts
- Excellent mathematical skills
- Excellent German and good English language skills

Desirable:

- Doctorate in a field of economics with a quantitative orientation
- Knowledge of statistics and/or econometrics
- Confident and friendly demeanour, outgoing and communicative
- High level of motivation, initiative and flexibility
- Teaching experience
- Ability to carry out the tasks independently

The position is open to all persons, irrespective of gender.

Due to the underrepresentation of women in equivalent positions at the university, applications from women are particularly welcome and will be treated with priority if they have the same qualifications and as long as there are no clear reasons which make a fellow applicant more suitable.

Severely disabled applicants with the same qualifications will be considered with preference.
